## **BRAUNSTONE AVENUE AREA - PROPOSED 20MPH ZONE**

Leicester City Council is proposing to introduce a 20mph zone in the area around Braunstone Avenue and Westcotes Drive. This is part of our commitment to improve road safety and encourage walking and cycling near to schools and in residential areas.

At the moment, the speed limit on these streets is 30 miles per hour and it is proposed to reduce this to 20 miles per hour. Existing measured mean traffic speeds in the area show that no traffic calming is necessary to slow vehicular speeds to below enforcement threshold levels. However, in order to try and discourage through traffic and reduce vehicular entry/exit speeds at the side roads. it is proposed to install flat topped road humps/continuous footway crossings on Dunster Street and Dulverton Road along with additional enhancement measures on Westcotes Drive. No traffic calming measures are currently proposed on the other roads in the area. The proposals are shown on the maps enclosed with this letter. Further information is available over the page.

The Council would like to hear your views on these matters.
