STONEYGATE ROAD AREA - PROPOSED 20MPH ZONE

Leicester City Council is proposing to introduce a 20mph Zone in the Stoneygate Road area. This is part of our commitment to improve road safety and encourage walking and cycling near to schools and in residential areas.

It is proposed to reduce the speed limit on the roads in this area to 20 miles per hour. Leicester City Council is not currently proposing to install any traffic calming measures on the roads in this area. The 20mph Zone area is shown on the map enclosed with this letter and further information is available over the page.

The Council would like to hear your views. A response form has been included with this letter so please complete and return this in the envelope provided by the 15th November 2024 (no stamp is required). The response form can also be filled in on-line at <http://consultations.leicester.gov.uk/>

The responses will be included in a report which goes to the City Mayor to decide whether to go ahead with the proposed changes or not.

1. The proposed speed limit change will affect the following streets:

2. It is estimated that the cost of the scheme will be around £10,000.
3. If this proposal is approved, then the change is likely to come into force in spring or summer of 2025.
