What are the ideas for changes?

The council wants to change how much money they allow for people who live at home and have a disability.



Everyone that can get help from the council has a financial assessment.

A **financial assessment** is when the council looks at all the money someone has coming in.



This is to work out if they have to pay towards the cost of their care, and if so, how much.



The financial assessment looks at extra costs that people may have because of their disability.

This is called **disability related expenditure (DRE)**.

Ideas for change



How does disability related expenditure work now?

The council works out if someone has to pay for their care and support and if so, how much.

Some people have extra costs because of a disability.



At the moment, the council allows a minimum of £20 per week (or £15 per week, for one of a couple).

We do allow people more than this, if they can show that their costs are higher.



What does the council want to change?

The council wants to change the amount they allow to a minimum of £10 per week, for everyone.

Due to budget cuts from central government, there is less money available to spend. Most people's actual expenses are less than £10 per week.

The council will continue to allow more than this, if people can show that their costs are higher. We think this idea is fairer.

How would the changes affect you and others



If this change is agreed, almost half of the people would not see any change at all.

They will either pay nothing as they do now, or will continue to pay the same amount each week.

This is because their income is too low, or they are already paying the full cost of their services.



While many people will not be asked to pay more, some people will be.

The amount each person pays will be different. Some people could start paying for the first time. The highest increase anyone would have to pay is £10 per week.
