The proposed changes are part of planning conditions imposed on Persimmon Homes in relation to the housing development off Laburnum Road. It is proposed to increase the number of streets which have a speed limit of 20 miles per hour. It is also proposed to install traffic calming on Fern Rise and Chestnut Avenue in order to reduce speeds and discourage through traffic. Further Information - Proposed 20 mph zone for the Laburnum Road Area

1. This proposed change will affect the following streets:

Buddleia Close	Whole Length
Chestnut Avenue	Whole Length
Fern Rise	Whole Length
Laburnum Road	Whole Length
Lilac Avenue	Whole Length
Rosebarn Way	Whole Length

- 2. For the period 1st January 2009 to 31st December 2013, there were 3 recorded personal injury accidents on streets affected by the proposals. One of the accidents involved injury to a child pedestrian.
- 3. The traffic calming features are proposed to be speed cushions which can be overridden by ambulances, fire tenders and buses. These cushions are manufactured from recycled shredded tyres and are bolted to the carriageway.
- 4. The proposed change is part of planning conditions imposed on Persimmon Homes in relation to the housing development off Laburnum Road. The developer is funding the scheme and there is no cost to Leicester City Council.
- 5. If this proposal for the Laburnum Road area is approved, then the changes are likely to come into force in the late autumn of 2014.
