## **Alteration description**

**4.** A description of the proposed alteration and in the case of special school proposals, a description of the current special needs provision.

Keyham Lodge is a community special school which provides 53 day places for boys with Social, Emotional and Behavioural Difficulties (SEBD).

- It is proposed to change the age range of Keyham Lodge School, from its current age range of 11 - 16, to an age range of 9 - 16.
- It is proposed to change the intake of pupils at the school from boys only to coeducational (boys and girls).
- It is proposed to enlarge the capacity of the school.

#### School capacity

The current capacity of the school is 53 and the proposed capacity is 126.

The school currently has 56 pupils on roll.

Additional capacity at the school will be available once the new school building is complete in February 2014.It is planned to gradually increase the number on roll over the next 5 years, subject to the demand for places.

#### **Objectives**

10. The objectives of the proposals.

The objectives of the proposals are:

- To provide additional specialised placements within the City for children and young people with Social, Emotional and Behavioural Difficulties (SEBD).
- To provide specialised placements for girls with SEBD within the City to prevent the need for girls to be educated in special provision outside the City and to reduce the need for expensive residential placements.
- To provide specialist placements for primary pupils (Year 5 and Year 6) with SEBD who require specialist teaching within smaller groups than are available within mainstream schools.

#### Consultation

    - The consultation commenced on 3 June 2013 and closed on 14 July 2013.
    - The consultation involved the distribution of consultation leaflets to a wide range of stakeholders including pupils, parents/carers, staff and their representatives, governors, diocesan authorities, all city schools and independent special schools where city pupils are currently placed.
    - Responses to the consultation were also sought from Leicestershire County Council, Leicester City Clinical Commissioning Group, University Hospitals of Leicester and local Members of Parliament.
    - The consultation was available on the council's website which allowed for online responses to be submitted.
    - The consultation was covered in a news article in the local paper.

- To support the consultation process a joint meeting was held on 11<sup>th</sup> June 2013 for staff and their representatives, governors and parents/carers of pupils at Keyham Lodge School and Millgate School. At the meeting the proposals were explained and those in attendance had the opportunity to ask questions.
- In total the Council received 11 responses relating to the proposals for Keyham Lodge School and Millgate School.
- Analysis of the responses shows support for the proposals for Keyham Lodge School.

The current school has a capacity of 53 places for boys only. It is proposed that the enlarged school will provide capacity for 126 pupils, including 20 places reserved for girls. All places are reserved for pupils with special educational needs. Pupils who are admitted to the school will have a statement of special educational needs or attend whilst the local authority carries out an assessment of their special educational needs.

It is proposed to establish places for girls at Keyham Lodge School. The council

currently places 11 girls in special schools outside of the city. These proposals will reduce the number of girls who need to travel on a daily basis to special schools outside the city and reduce the number of girls who are places in residential special schools.

Of the 18 mainstream secondary schools in Leicester City, 14 are co-educational and 4 are single sex (2 boys only and 2 girls only). Of the 6 special schools that admit pupils of secondary age, 4 are currently co-educational with Keyham Lodge School and Millgate School only providing places for boys. There is a demand for places for girls with SEBD in the city but there are not sufficient numbers to warrant a special school for girls only.
