Statement of Compliance with the Duty to Cooperate November 2022

1. Introduction

- 1.1 Section 110 of the Localism Act 2011 introduced the legal 'Duty to Cooperate, into Section 33A of the Planning and Compulsory Purchase Act 2004 which requires local planning authorities to work with other neighbouring authorities and other prescribed bodies in preparing development plan documents.
- 1.2 Relevant planning issues identified for consideration under the duty include the development or use of land that would have a significant impact on at least two planning areas (and in particular on strategic infrastructure). A local planning authority should 'engage constructively, actively and on an ongoing basis', in respect of the activities that are subject to the duty.
- 1.3 The list of 'other prescribed bodies' is set out in the Town and Country Planning (Local Planning) (England) Regulations 2012 and those which apply to Leicester are:
 - The Environment Agency
 - Historic England
 - Natural England
 - Homes England
 - Leicester, Leicestershire and Rutland Clinical Commissioning Groups, Leicestershire Partnership NHS Trust and University Hospitals of Leicester NHS Trust.
 - National Health Service (NHS) England
 - Network Rail
 - Highway authorities within the meaning of section 1 of the Highways Act 1980 including the Secretary of State, i.e. Highways England (now National Highways)
 - Sport England
- 1.4 The Regulations also make clear that when preparing plans, local authorities should also have regard to Local Enterprise Partnerships (LEP) and Local Nature Partnerships (LNP). The relevant LEP is Leicester and Leicestershire LEP and the relevant LNP is Leicestershire Local Nature Partnership.
- 1.5 The National Planning Policy Framework sets out that authorities should prepare Statements of Common Ground throughout the plan-making process to evidence effective joint working on cross-boundary strategic matters. National Planning Practice Guidance (NPPG) defines a Statement of Common Ground as a written record of the progress made by strategic policy-making authorities during the process of planning for strategic cross-boundary matters. It documents where effective cooperation is and is not, happening throughout the plan-making process. It also provides evidence to demonstrate that the duty to cooperate has been complied with.

2. Cooperation on Strategic Planning Matters across Leicester and Leicestershire


2.1 Effective cooperation with other local authorities across Leicester and Leicestershire has been well established over many years and was strengthened by the joint work to prepare and agree the Leicester and Leicestershire Strategic Growth Plan (SGP). This is a non-statutory plan to shape the future of the Leicester and Leicestershire Housing Market Area (HMA) and Functional Economic Market Area (FEMA) in the period to 2050. It provides a long-term vision and a jointly agreed framework on cross boundary matters that partners can use to inform their individual statutory local plans. It was approved in 2018 by all the Leicester and Leicestershire local authorities and the Leicester and Leicestershire Local Enterprise Partnership (LLEP). The Strategic Growth Plan focuses on delivering new housing, supporting the economy, identifying essential infrastructure, and protecting the environment and built heritage. Leicestershire local authorities and the LLEP work collaboratively to address these strategic issues and implement the vision.

- 2.2 Joint strategic planning work is overseen by the Members' Advisory Group (MAG). The MAG comprises a councillor from each of the authorities, plus an observer from the Leicester and Leicestershire Local Enterprise Partnership (LLEP) and it meets on a regular basis, currently every two months. Any proposals or recommendations of the MAG pertaining to key strategic planning issues are subject to ratification by individual local authorities.
- 2.3 MAG is supported by a Strategic Planning Group (SPG) made up of senior officer representatives responsible for overseeing strategic planning in each of the constituent authorities. SPG meets on a regular basis, currently monthly. The SPG is itself supported by further officer groups; including the Planning Officers' Forum (POF), which is a formal meeting of Chief Officers responsible for planning and transport services across Leicester and Leicestershire. The Forum provides professional advice to the SPG and is supported by joint officer level meetings, which includes managers responsible for planning and transportation policy within Leicester and Leicestershire.
- 2.4 The POF is also supported by the Task & Finish Group (T&F) which comprises senior officers that meet every week to work together on the strategic matters including housing, employment, transport and associated evidence studies. The T&F group supports and advises both POF and SPG.
- 2.5 The key strategic matter for Leicester and Leicestershire relates to housing and employment and involves a number of work streams to address the issue of unmet housing and employment arising in Leicester. This has involved collaborative working on the following studies:
 - Housing and Economic Needs Assessment (HENA) a study to better understand the need for housing and employment land including the type and mix needed within Leicester and Leicestershire
 - Sustainability Appraisal (SA) to appraise and inform the distribution options and scenarios considered in the Statement of Common Ground.
 - Strategic Transport Assessment (STA) to develop a series of growth scenarios to understand the impacts of growth on the transport network
 - Strategic Growth Options and Constraints Mapping (SGO) to assess the potential of strategic sites in Leicestershire and understand the opportunities and constraints at a strategic scale
 - Warehousing and Logistics in Leicester and Leicestershire: Managing growth and change – assesses the need for Large Warehousing and Logistics 2020 – 2041
- 2.6 Following completion of this evidence excluding the Transport Assessment and the Strategic Growth Options, Leicestershire local authorities have agreed options for accommodating the unmet need. A Statement of Common Ground on the apportionment of Leicester's unmet need has been agreed and is going through individual governance process across areas. Transport Assessment and Strategic

Growth Options are currently being prepared and will inform the longer term growth through the SGP.

3. Leicester's Local Plan

3.1 Relevant bodies have been consulted, both formally and informally, throughout the stages of the preparation of the Leicester Local Plan. The stages of this consultation are shown in the diagram below.



- 3.2 The table below provides a summary of all the relevant duty to cooperate bodies engaged with, the strategic matters which we have worked with partner bodies on and how the issues have been resolved.
- 3.3 There will continue to be engagement with all partners, as necessary, to finalise and implement the Local Plan. This will include engagement through the established structure for strategic planning in Leicester and Leicestershire to address issues arising from the objectively assessed housing and employment needs that cannot be met wholly within Leicester.
