FAIRFAX ROAD AREA – PROPOSED 20MPH ZONE.

Leicester City Council is proposing to introduce a 20mph Zone in the Fairfax Road Area. This proposal will involve changing the speed limit to 20 miles per hour.

At the moment, the speed limit on these streets is 30 miles per hour and the Council is proposing to reduce this to 20 miles per hour in order to improve road safety. The proposals are shown on the map enclosed with this letter. If you would like further information please see over the page.

The Council would like to hear your views on these matters.



1. The proposed speed limit change will affect the following streets:

Dunbar Road	Whole Length

- 2 For the period 1st January 2011 to 31st December 2015, there were 7 recorded personal injury accidents on the streets affected by the proposals. Two of these accidents involved injury to pedestrians.
- 3 These proposals are part of a programme of new 20mph zones which has been confirmed by the City Mayor. Money has been set aside by the Council from the Integrated Capital Programme to pay for these changes. It is estimated that the cost of the scheme will be £11,000.
- 4 If this proposal is approved, then the change is likely to come into force late in 2016.
