YORKSHIRE ROAD AREA– PROPOSED 20MPH SPEED LIMIT.

Leicester City Council is proposing to introduce a 20mph speed limit in the Yorkshire Road area. This is part of our commitment to improve road safety and encourage walking and cycling near to schools and in residential areas.

At present, the speed limit on these streets is 30 miles per hour and the Council is proposing to reduce this to 20 miles per hour. The proposals are shown on the map enclosed with this letter. Further information is available over the page.

Speed surveys carried out in the area have shown average speeds are already suitable for a 20mph speed limit. There are no proposals to install further traffic calming features.

The Council would like to hear your views on these matters.

Your response will be included in a report on the proposals which goes to the City Mayor who will decide whether to go ahead with the proposed changes or not.
